### **REPAYMENT PROPOSAL FOR HELP LOAN - LOS ROBLES PROJECT**

City Manager Jeff Kiser gave a staff report and, together with Assistant City Manager/Finance Director Liz Cottrell, answered questions from the Board. Ms. Cottrell explained that while the Successor Agency is not receiving enough funds annually to pay this loan, due to receiving a repayment of another low-mod housing loan, there are enough funds in the housing account to make the proposed 20% down payment of \$84,000 and the first two annual payments of \$50,000 each.

By motion made, seconded (Baugh/Fincher), and carried by a 4-0 vote, the Board directed staff to continue negotiations with CalHFA to try to eliminate or reduce accrued interest and bring the matter back to the Board for approval.

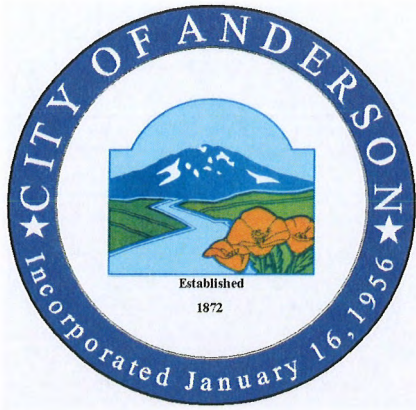

**Repayment Proposal for HELP Loan - Los Robles Project**

**RECOMMENDATION**

The City Manager recommends the Oversight Board:

**Approve proposed repayment plan for HELP Loan #080803-01**

**DISCUSSION and BACKGROUND**

At the Oversight Board meeting of March 24, 2014, the Board directed staff to revisit negotiations with CalHFA on a modified payment schedule for the HELP Loan to try to eliminate or reduce accrued interest. CalHFA's response to interest forgiveness is they are not able to forgive any of the accrued interest due to the fact that loans such as these made to Cities, Counties and RDA's were made with their own funds. These funds need to be repaid to allow CalHFA to continue operating.

It is our understanding in talking with CalHFA; they have not forgiven any accrued interest with any agency. After discussions with the CalHFA representatives however, staff is proposing the following:

1. A 20% down payment of \$ 84,000.00
2. Annual payments of \$ 50,000.00
3. Balloon payment by March 9, 2017
4. 0% interest going forward on remaining balance.
