REGULAR SESSION

The regular Council meeting was called to order at 7:01 p.m.

ROLL CALL

PUBLIC WORKS DEPARTMENT

AWARD BID FOR THE I-5 WATER MAIN CROSSING PROJECT

Deputy Public Works Director Kevin Kidd gave a staff report and answered questions from Council.

By motion made, seconded (Webster/Burnett), and carried, the Council awarded the contract for the I-5 Water Main Crossing Project to the low bidder Sierra National Construction of Carmichael, California in the amount of \$123,370, authorized the City Manager to execute the contract upon receipt of required insurance certificates and payment and performance bonds, and authorized the Public Works Director to approve project change orders not to exceed 20% of the contract bid amount.
