SUBJECT

Support for State Appropriation of Non-General Funds for Courthouse Construction

RECOMMENDATION

The City Manager recommends that the City Council:

Adopt a resolution supporting State appropriation of non-General Fund revenue for expedited courthouse construction throughout California, including within Shasta County.

DISCUSSION and BACKGROUND

This resolution would put the City of Anderson on record as supporting a continuous non-General Fund appropriation for courthouse construction, as authorized under Senate Bill 1407.

RESOLUTION NO. 09-_____

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF ANDERSON
SUPPORTING STATE APPROPRIATION OF NON-GENERAL FUND REVENUE
FOR EXPEDITED COURTHOUSE CONSTRUCTION THROUGHOUT CALIFORNIA,
INCLUDING WITHIN SHASTA COUNTY

WHEREAS, State non-General Fund revenue generated by Senate Bill 1407 (Statutes 2008, Chapter 311) is to be use to build courthouses throughout California; and

WHEREAS, California's economy needs an expedited continuous appropriation of these non-General Funds to create construction jobs and needed courtrooms; and

WHEREAS, the State Judicial Council estimates that the total program would provide California with over 100,000 new jobs and over \$11 billion in goods and services, all without impacting the State General Fund; and

WHEREAS, the continuous appropriation of funds generated by Senate Bill 1407 will support the construction of a new courthouse within Shasta County, a courthouse that will provide fourteen courtrooms to replace existing facilities that are physically deficient, overcrowded, and having substandard security features.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Anderson as follows:

Section 1. The City Council supports a continuous appropriation of State of California non-General Funds under Senate Bill 1407 for the construction of new courthouses throughout California, including within Shasta County.

Section 2. The City Council hereby authorizes the Mayor to communicate this support to appropriate State elected and appointed officials.
